

DMV Soft Lens Handler™

Remover / Inserter for Soft Contact Lenses

Intended Use

DMV Soft Lens handler is designed for inserting and removing soft contact lenses.

Instructions for Use

Before using the first time, clean the device with 70% isopropyl alcohol and allow to air dry.

REMOVAL – Press the gripper pads firmly against the front of the soft contact lens. Be sure that the lens is on the cornea by using a mirror. Gently squeeze the grippers together to extract the contact lens.

INSERTION – Place a wet contact lens on the small end of the device where the arrow indicates. Allow the lens to overlap the end of the device so you can view your progress through the lens.

Follow the directions of your contact lens fitter / eye care professional.

Cleaning

Each time after using the device clean it with 70% isopropyl alcohol and allow to air dry. Store the device in its case after dry. Plan to replace it every six months.



Precaution: If you apply the device accidentally to the surface of the eye, merely withdraw it from the eye, as there is no suction. Avoid sliding the device over the surface of the eye.



Caution: Please keep this product away from liquids such as hand cream, hair gels, nail polish remover and strong oxidizing agents.



Caution: Choking hazard. Keep this and all other medical devices away from small children.

This product is not recommended to be used with diseased or injured eyes. If you experience an irritated eye, unusual visual impairment or pain, consult your eye care professional.



Caution: Though there is no evidence of allergy issues with this product, it does contain dry natural rubber. It does not contain liquid latex, a known allergen.

DO NOT USE this device with hard, gas permeable, scleral or hybrid contact lenses.
